An Interesting Read

Attached to this Newsletter email are two articles that, although quite different, both present thought-provoking concepts.

The CODE: a practical framework for advancing patient-centred code status discussions reflects that code status preference is frequently ignored, misunderstood or improperly documented, which represents a real patient safety issue resulting in preventable harm. Every patient admitted to a hospital, scheduled for a procedure or facing a life-limiting illness potentially confronts a decision about cardiopulmonary resuscitation (CPR).

The Creating a pathway for public hospital accreditation in Rwanda: progress, challenges and lessons learned article presents the difficulties of introducing accreditation into the Rwanda system.

Health systems worldwide have embraced hospital accreditation as a mechanism for bolstering patient safety and quality. Though interest in hospital accreditation in low-and-middle income countries (LMICs) is growing after decades of focus on high-income countries, uptake and success of accreditation initiatives in LMICs has been variable. This paper summarises the experience of Rwanda, an East African country of 12 million people, in developing its own national hospital accreditation system.

Updates to ISO 31000 Risk Management Standard

The opening words to this standard are very pertinent to today's environment. Who would have thought in 2018 when this standard was revised how pertinent it would be today!!

"We live in an ever-changing world where we are forced to deal with uncertainty every day. But how an organization tackles that uncertainty can be a key predictor of its success".

Members should be aware for policy updates that this standard was revised in 2018 (last version 2009) and has a more contemporary approach for system requirements.

Using the Delphi Method to Engage Stakeholders in COVID-19 times

The Australian Healthcare and Hospitals Association (AHHA) recently published an way of engaging with stakeholders.

'An effective methodology that the AHHA has used to engage stakeholders where face-to-face contact is not possible is the Delphi method', says AHHA Chief Executive Alison Verhoeven.

The AHHA article suggests the method works on the premise that group opinion is more valid than individual opinion. It is especially useful for obtaining and integrating the opinions of a group of expert individuals about a complex problem or issue - particularly where there is incomplete knowledge.

The use of the <u>Delphi method for remote consultations</u> discusses considerations when designing engagement activities, including leveraging strengths, mitigating risks, and adapting the method to best meet the purposes of the engagement.

'The Delphi method has been criticised by some as a move away from quantitative scientific evidence to qualitative opinion. However, for many issues, COVID-19 included, quantitative evidence can be lacking or inconclusive, yet it's important that good decisions based on collective expertise be made right now.

'The Delphi method has been proven to yield good, defensible results. Nevertheless, good question design, collation of responses, research and dissemination of outcomes are critical, as is the administering team's ability to construct further questions to support experts in re-evaluating their original responses.'

The Australian Commission on Safety and Quality

The Commission has released new guidance, available <u>here</u>, addressing Non-tuberculous *Mycobacterium* associated with heater-cooler devices

For noting, the Commission recommends a range of actions for health service organisations to consider, including those relating to Governance:

A senior person should be designated within the local health service organisation to coordinate response strategies such as:

Identifying and testing relevant equipment

- Ensuring the results of confirmed Mycobacterium chimaera contamination are reported to the TGA, the manufacturer of the device, and the relevant state or territory government contact (see Section 7 for contact details)
- Establishing policies and procedures to minimise exposure risk to patients, and to enable service continuity. Guidance in this regard is provided in Sections 2 to 6
- Communicating the potential for risk and local response strategies to senior management, relevant clinicians and primary health providers. This may include the hospital executive as well as infection prevention and control, infectious diseases, cardiac surgery, perfusion, anaesthesia, clinical microbiology and anatomical pathology services
- Ensuring systems for maintaining records of HCD testing, maintenance and use are in place (Section 3).

If this equipment is applicable to your organisation the full guide should be tabled at an infection prevention and control meeting.

In terms of accreditation evidence, a suggestion would be to include this as part of 3.12a, noting also the links with:

- 3.1a policies and procedures
- 3.1b risk management
- 3.4 possibly 3/12 surveillance of the testing of the device.

COVID-19 Infection Control Training

The Australian Government Department of Health is promoting a 30minute online training module which covers the fundamentals of infection prevention and control for COVID-19.

It is aimed at health care workers in all settings including:

- hospitals
- primary care
- aged care (both in residential aged care facilities or with visiting carers at home, including cleaners and cooks)
- disability (both in residential/shared care facilities or part-time carers in people's homes, including cleaners and cooks)
- allied health
- Aboriginal Community Controlled Health Services
- pharmacies
- dental practices, including dentists, nurses, cleaners and receptionists

The module covers the fundamentals of infection prevention and control for COVID-19 including:

- COVID-19 what is it?
- Signs and symptoms
- Keeping safe protecting yourself and others

Australian Commission on Safety and Quality in Health Care

The Commission is seeking feedback on the draft National Safety and Quality Health Service (NSQHS) Standards User guide for health service organisations providing care for patients from migrant and refugee backgrounds (the user guide).

This user guide provides information for health service organisations on recommended approaches to delivering culturally responsive care that is safe and of high quality to patients from migrant and refugee backgrounds.

It contains practical strategies and examples for improving care for people from migrant and refugee backgrounds.

The only three numbers you need to know in healthcare

What is preventing the health system from providing better care to patients?

60% of healthcare is evidence-based 30% is waste 10% is harm

Professor Jeffrey Braithwaite, declares that while hospitals and the health system are innovating to meet new challenges every day, performance has flatlined. His research points to a three-pronged challenge standing in the way of progress:

- 60% of care on average is in line with evidence- or consensusbased guidelines,
- 30% is some form of waste or of low value, and
- 10% causes harm to patients.

The latest issue of the Australian Institute of Health Innovation (AIHI) Innovate explains an exploration of these issues and strategies for the future are explored in the open access BMC Medicine article <u>"The three numbers you need to know about healthcare: the 60-30-10 Challenge"</u> by Professors Jeffrey Braithwaite and Johanna Westbrook from AIHI and Professor Paul Glasziou from Bond University.

Latest News from Aged Care

The Aged Care Quality and Safety Commission's <u>Aged Care Quality</u> <u>Bulletin</u> for May has been released.

The Commissioner says that while the current trends in relation to the COVID-19 pandemic are broadly reassuring across Australia, there are still very serious risks for older Australians, which means we must not relax our current vigilance.

The Commission is continuing to adapt its regulatory response to keep consumers safe and to provide guidance and support to providers in delivering safe, effective, compassionate and high-quality care.

The latest Departmental information on COVID-19can be found in the national guidelines for the prevention, control and public health management of COVID-19 outbreaks in residential care facilities developed by the Communicable Diseases Network Australia (CDNA).

Other information can be obtained via a <u>fact sheet on outbreak</u> <u>management in residential aged care facilities</u>.

Aged Care Visitor Access Code

An Industry Code for Visiting Residential Aged Care Homes during <u>COVID-19</u> has been released by aged care peak bodies and consumer advocacy organisations.

The Code creates a nationally consistent approach that ensures residents can receive visitors while minimising the risk of spreading COVID-19. The

Code was finalised after public consultation with consumers and aged care providers.

The Code includes the respective rights and responsibilities of providers, residents and visitors. It also outlines that residential aged care services should allow residents to meet their visitors in a way that minimises the risk of COVID-19 being introduced or spread within a residential facility.

Applying for Fellow or Associate Fellow Credentialing

Applications are now being accepted for the program in 2020. This is a great way to receive recognition for your role in quality.
