Are you interested in accessing an on-line course to put quality improvement into practice?

The AAQHC are seeking expressions of interest from members to access the Institute for Healthcare Improvement's
Quality Improvement Practicum commencing September 24, 2019.

What you need to do:

In less than 100 words, outline why this course would be of benefit to you as a quality manager.

Who can apply?

- Members who have 3 years continuous membership with the AAQHC, and
- Are **currently employed** in a quality improvement position.

Application Process:

- 1. Review the <u>requirements</u> to ensure you can complete the 9-week practicum.
- 2. Send 100 words or less to aaqhc@aaqhc.org.au outlining why this course would be of benefit to you as a quality manager.
 - Applications must reach the AAQHC by Friday 6th September.
- 3. The successful applicant will be notified by the AAQHC.
- 4. At the completion of the course, the successful applicant will be required to submit a summary report of the course outlining the benefits gained from completing the course. The report will be published in the December 2019 AAQHC newsletter.

Note:

- The course is to the value of \$549 which the AAQHC will provide.
- Applications will be judged by members of the AAQHC Council.
- No enquiries will be entered into, the decision of the judging panel will be final.
- If the course is not completed, or a report is not received for publication, a full refund will be required to be paid to the AAQHC.
- Completion of the course will support eligibility for Associate Fellow of the AAQHC.

Applying for Fellow or Associate Fellow Credentialing

Applications are now being accepted for the program in 2019.
